

“Tis The Season” OPERATION SANTA CLAUS OFFICIAL RULES

Contest Name: Season Ticket Giveaway, Operation Santa Claus (the “Contest”)

Company: Sanderson Ford and Sanderson Lincoln Operation Santa Claus is a 501(c) (3) charity #26-1558976 to raise donations for St. Mary’s Food Bank Alliance, Ronald McDonald House Charities of Phoenix, Southwest Autism Research & Resource Center (SARRC), Special Olympics Arizona (SOAZ) and Military Assistance Mission (MAM). Participants are requested to make voluntary donation(s) of non-perishable foods, new toys, child size clothing, and or monetary donations. Any donations made prior to Friday, July 27, 2018 or after Friday, August 31, 2018 will not be eligible to win. The cut off for all entries is Friday, August 31, 2018 at 6:00pm MST.

Or make a donation in person at The Arizona Cardinals Training Camp located at the University of Phoenix Stadium, in Glendale, AZ (a representative will be on-site collecting donations between 1:30pm-4:30pm on Saturday, August 4th, 2018).

Entries received after Friday, August 31, 2018 at 6:00pm MST will not be eligible.

Other Requirements and information:

Winners must be at least 18 years of age by Friday, July 27, 2018, be AZ residents, with a valid current driver’s license. Employees and members of their immediate family of Sanderson Ford, Sanderson Lincoln, The Arizona Cardinals and participating radio stations are not eligible to participate and win.
